(b) Discussion on setting up one drive to send meeting information to council for meeting. Clerk Bennett and Bursej will look into this.

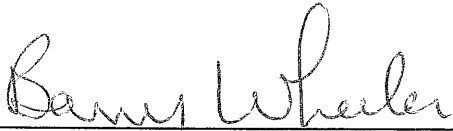

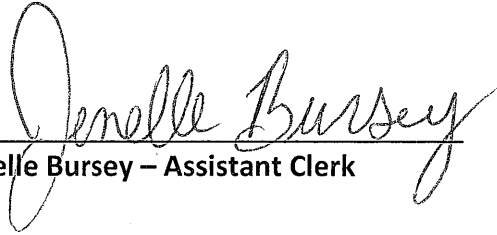
